RESOLUTION NO. 2022-07

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO ESTABLISHING A SOLE SOURCE PROVIDER AND AUTHORIZING THE PURCHASE AND INSTALLATION OF POLICE AND EMERGENCY VEHICLE EQUIPMENT FROM SYSTEMS FOR PUBLIC SAFETY

WHEREAS, the City has a fleet of police and emergency vehicles; and

WHEREAS, the City requires consistency in the police and emergency vehicle equipment and installation of the equipment to facilitate the use and functioning of equipment by different officers and employees; and

WHEREAS, it is critical for the City of Poulsbo to have proper equipment and installation to perform police and emergency functions; and

WHEREAS, many city, county and state agencies currently utilize Systems for Public Safety because of the quality and timeliness of their service; and

WHEREAS, Systems for Public Safety specializes in police and emergency equipment and offers a package service of both providing and installing the desired equipment. There are other suppliers who sell some of the equipment but do not install, and others who have only a few pieces of equipment that they can supply and install. Systems for Public Safety is unique in providing both the equipment that the City has determined to best meet the City's needs and the installation of that equipment. Using Systems for Public Safety is also more efficient, timely and accurate because the supplier is responsible for ordering the equipment that meets the Police Department specifications

and ensuring it is the correct model that can be properly installed in the Police or emergency vehicles; and

WHEREAS, the specialized supplier and installer of the desired police and emergency vehicle equipment is clearly and legitimately limited to a single source of supply within the local area. This justifies waiving competitive bidding requirements per RCW 35.23.352(9) competitive bidding exemptions, RCW 39.04.280(1)(a) sole source, and RCW 39.04.280(1)(b) special market condition; and

WHEREAS, Systems for Public Safety (SPS) is a factory authorized warranty center for all products they supply and is a certified or master distributor of these products. SPS is the only company in our region that offers all required emergency vehicle products with certified installation and knowledge availability of new equipment or products that must be compatible with existing Police and Public Works equipment or products; and

WHEREAS, the System for Public Safety meets the needs and is best suited for the City of Poulsbo;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO, HEREBY


RESOLVES AS FOLLOWS:

Section 1. Approval and Adoption. The Poulsbo City Council finds that it is in the best interest of the public based upon the above-described circumstance to justify the waiver of bidding requirements under the authority of RCW 35.23.352(9) and pursuant to sole source provider RCW 39.04.280(1)(a) and special market conditions RCW 39.04.280(1)(a) and (b). The Poulsbo City Council thereby approves and adopts the sole source agreement for the City of

Poulsbo Police Department to purchase police and emergency vehicle equipment and installation services from Systems for Public Safety.
