Planning Commission regarding the proposed project.

Poulsbo is required to adopt a stormwater design manual with guidelines and technical **Project Description:**

requirements for new development and redevelopment projects to ensure compliance with all local, state, and federal regulations. The Washington State Department of Ecology (Ecology) publishes stormwater manuals which comply with those regulations. Ecology issues a National Pollution Discharge Elimination System (NPDES) Permit to the City of Poulsbo, and one of the permit requirements is that the City shall adopt the 2019 Stormwater Management Manual for Western Washington with an effective date of July 1st, 2022. Section 12.02.030 of the Poulsbo

Municipal Code needs to be amended to adopt the new manual.
