## STORMWATER MANUAL ADOPTION, TYPE IV Planning Commission Public Hearing: April 26, 2022

<b>Hearing Date:</b>	April 26, 2022	<b>Hearing Time:</b>	The hearing is scheduled to begin at 7 pm.
<b>Requested Action:</b>	All interested citizens and agencies are invited to provide written and verbal testimony to the Planning Commission regarding the proposed project.		
<b>Project Description:</b>	Poulsbo is required to adopt a stormwater design manual with guidelines and technical requirements for new development and redevelopment projects to ensure compliance with all local, state, and federal regulations. The Washington State Department of Ecology (Ecology) publishes stormwater manuals which comply with those regulations. Ecology issues a National Pollution Discharge Elimination System (NPDES) Permit to the City of Poulsbo, and one of the permit requirements is that the City shall adopt the 2019 Stormwater Management Manual for Western Washington with an effective date of July 1st, 2022. Section 12.02.030 of the Poulsbo Municipal Code needs to be amended to adopt the new manual.		
<b>Public Comment Methods:</b>	Written comments may be e-mailed to the PED staff contact indicated below. To ensure consideration, all written comments must be received by the city prior to close of the public hearing. At the hearing, the public will have an opportunity to provide written and verbal testimony.
