Subject: Sales Tax by Zone Report for 2021 Year-End

2020 through 2021 (2-year comparison) 2017 through 2021 (5-year detail) 2011, 2016, 2021 (10-year trend)

Please find attached several graphs and charts reflecting the sales tax dollars received for 2021 with comparison analysis of 2-years and 5-years in detail along with a 10-year trend. The past two years of sales tax by percentage and dollars are presented on pages 1 and 2. The past five years of sales tax by dollars and percentages for each zone are presented on pages 3 and 4. The ten-year trend of sales tax by dollars and percentages for each zone are presented on pages 5 and 6.

As you will notice, the percentage of sales tax by zone remains consistent over the years, with actual revenues by zone having exceeded pre-pandemic levels in 2021. The increase in revenues outside the city limits has been steadily increasing in prior years, but the pandemic expediated the shift more quickly since consumers purchased products and services online versus in store. Local businesses worked diligently to adapt to the changes in economic conditions, an effort which would appear to have been successful in 2021. Sales tax revenues exceeded budgeted expectations by just under nine hundred thousand, making the 2021-year sales tax revenue the highest the city has seen over the past 10 years.

This report reflects the sales tax paid for the months of January through December.






