ORDINANCE NO. 2022-06

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SECTION 12.02.030 OF THE POULSBO MUNICIPAL CODE IN ORDER TO ADOPT THE 2019 STORMWATER MANAGEMENT MANUAL FOR WESTERN WASHINGTON AND REMAIN IN COMPLIANCE WITH THE CURRENT NPDES PERMIT; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE OF JULY 1, 2022.

WHEREAS, Section 12.02.030 of the Poulsbo Municipal Code regulates Stormwater Design Manual Adoption in the City; and

WHEREAS, The NPDES Municipal Stormwater Permit requires City of Poulsbo to adopt stormwater manuals periodically as they are updated; and

WHEREAS, Section 12.02.030 is required to be amended to adopt the 2019 Stormwater Management Manual for Western Washington; and

WHEREAS, On March 18, 2022, the City released the 2019 Stormwater Manual Adoption package and public participation plan to the public, state and local agencies and interested parties; and

WHEREAS, The Poulsbo Planning Commission held a workshop and duly noticed public hearing on April 26, 2022 in order to obtain public input; and

WHEREAS, The Poulsbo Planning Commission recommended that the Poulsbo City Council approve the 2019 Stormwater Manual Adoption package and amendments to Section 12.02.030 of the PMC; and

WHEREAS, The Poulsbo City Council held a duly noticed public hearing on the 2019 Stormwater Manual adoption package on May 11, 2022 in order to obtain public input on the proposed amendments; and

WHEREAS, After considering the public testimony, and other available information, the Poulsbo City Council determined on May 11, 2022 to accept the 2019 Stormwater Manual Adoption package amending Section 12.02.030 of the Poulsbo Municipal Code; NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Adoption of Findings. The recitals set forth above are hereby adopted as the Poulsbo City Council's findings justifying the revisions to the chapter of code adopted by this ordinance.

Section 2. Amendment of PMC Section 12.02.030. Section 12.02.030 of the Poulsbo Municipal Code is hereby amended as shown:

PMC 12.02.030 Stormwater Design Manual Adoption

The city of Poulsbo hereby adopts the following stormwater design and guidance manuals for all new development, redevelopment and construction projects within the city of Poulsbo subject to the minimum requirements, technical thresholds and definitions contained within the manuals as adopted in this section:

- A. The 2019 Stormwater Management Manual for Western Washington (SWMMWW) published by Department of Ecology.
- B. Low Impact Development: Technical Guidance Manual for Puget Sound, December 2012.
- C. The Washington State Department of Transportation Highway Runoff Manual, as determined by the Washington State Department of Ecology to be equivalent to the 2019 Department of Ecology Stormwater Management Manual for Western Washington, may be used when required by state or federal funding requirements.

Section 3. Severability. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance or its application to any person or situation should be held to be invalid or unconstitutional for any reason by a court of competent jurisdiction, such invalidity or

unconstitutionality shall not affect the validity or constitutionality of the remaining portions of this ordinance or its application to any other person or situation.

Section 4. Effective Date. This ordinance shall be in force and effective on July 1, 2022, after its passage by Poulsbo City Council and publication in the summary form attached to this ordinance.
