**ORDINANCE NO. 2022-08**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SECTION 2.40.040 OF THE CITY OF POULSBO MUNICIPAL CODE IN ORDER TO CHANGE THE PLANNING COMMISSION MEETING START TIME FROM 7PM TO 6PM; AND PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, on May 24, 2022, the notice of Planning Commission Public Hearing and City Council Public Hearing was published in the Seattle Times, posted at the Poulsbo Library, Poulsbo Post Office, City Hall, and the city's website; and

**WHEREAS**, on June 7, 2022, the Planning Commission held a duly noticed public hearing on the Planning Commission Meeting Time Change Amendment; and

**WHEREAS**, after considering the testimony received at the public hearing, the Planning Commission voted to recommend approval of the Planning Commission Meeting Time Change Amendment to the Poulsbo City Council, and adopted findings of fact in support of their decision; and

**WHEREAS**, the Poulsbo City Council held a duly noticed public hearing on the Planning Commission Meeting Time Change Amendment on June 15, 2022; and

**WHEREAS**, after considering the staff and Planning Commission recommendations and all public testimony received in the public hearing, the Poulsbo City Council determined to approve and to adopt the final document by the passage of this ordinance;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. Findings and Conclusions.** In support of the actions taken by this ordinance, the Poulsbo City Council hereby adopts the following as findings and conclusions:

- A. The recitals set forth above; and
- B. The findings, conclusions, and analysis contained in the Planning Commission Findings of Fact and Recommendation.

**Section 2. Planning Commission Meeting Time Change Amendment.** Poulsbo Municipal Code section 2.40 is hereby amended as set forth in Attachment A to this ordinance.

**Section 3. Severability.** If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 4. Effective Date.** This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.





### **Poulsbo Municipal Code Chapter 2.40.040 - Meetings**

The planning commission shall meet on the second and fourth Tuesday of each month at ~~six seven~~ p.m. ~~in City Hall~~. In the event that any regular meeting date falls upon a city holiday, the meeting shall be conducted on the next regular business day unless a special meeting date is set in advance. All meetings, both regular and special, shall be open to the public and shall be conducted in accord with Chapter [42.30](#) RCW, the State Open Public Meetings Act.
