AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING CHAPTER 3.56 OF THE POULSBO MUNICIPAL CODE AND ABOLISHING THE POLICE INVESTIGATIVE REVOLVING FUND, ESTABLISHING AN EFFECTIVE DATE, AND APPROVING A SUMMARY FOR PUBLICATION.

WHEREAS, Chapter 3.56 of the Poulsbo Municipal Code establishes the police investigative revolving fund for the purpose of disbursing monies to police officers involved in investigative work, and


WHEREAS, there are no monies in the fund at the present time and the Police Chief and Finance Director have recommended that Chapter 3.56 be repealed and the fund abolished, and

WHEREAS, the Poulsbo City Council concurs in the recommendation, now, therefore,
THE CITY COUNCIL OF THE CITY OF POULBO, WASHINGTON, HEREBY ORDAIN AS
FOLLOWS:

Section 1. Chapter 3.56 Repealed. Chapter 3.56 of the Poulsbo Municipal Code is hereby repealed and the police investigative revolving fund is hereby abolished.


Section 2. Effective Date. This ordinance shall take effect and be in full force five (5) days after publication of the attached summary which is hereby approved.


