Requested Action:	All interested citizens and agencies are invited to provide written and verbal testimony to the City Council regarding the proposed project.		
Applicant:	Poulsbo Engineering Dept. 200 NE Moe Street Poulsbo, WA 98370		
Project Description:	Chapter 15.24 of the Poulsbo Municipal Code (PMC) regulates and manages development in areas of special flood hazard within the city. The City's adoption and enforcement of PMC Chapter 15.24, Floodplain Management, promotes public health, safety, and welfare by reducing loss of life and property damage due to flooding and by minimizing expenditures for flood control projects and for rescue and relief operations. Chapter 15.24 allows property owners in the City of Poulsbo to purchase flood insurance through the National Flood Insurance Program (NFIP). In 2021, the Washington State Department of Ecology performed a Community Assistance Contact, evaluating the City's flood management program. As part of the assistance, Ecology staff reviewed Chapter 15.24 for compliance with current FEMA National Flood Insurance Program requirements, identifying changes needed to stay current.
