### ***THE FOLLOWING ITEMS ARE NOT ACCEPTED IN ANY CITY CONTAINER...***

- TOXIC OR HAZARDOUS MATERIALS– BATTERIES, MOTOR OIL
- PAINT, PETROLEUM PRODUCTS, SOLVENTS, CHEMICALS
- TIRES, APPLIANCES, COMPUTER MONITORS, TELEVISIONS
- CONCRETE, ROCKS OR SOD, LAWN MOWERS, BBQ'S
- LARGE RECYCLABLE ITEMS– METAL AND BI-METAL PRODUCTS
- MATTRESSES, FURNITURE ETC.

ALL CONTAINERS WILL BE INSPECTED BY PUBLIC WORKS STAFF FOR COMPLIANCE PRIOR TO ACCEPTANCE AND DISPOSAL OF SOLID WASTE.

## PROPERLY MAINTAIN DUMPSTER AREAS

- PER PMC 8.16.040(B)(4), THE PROPERTY OWNER SHALL MAINTAIN CONTAINERS, LIDS AND DUMPSTERS IN A CLEAN/ SERVICEABLE CONDITION.
- KEEP DUMPSTER LIDS CLOSED TO KEEP OUT RAINWATER
- KEEP THE AREA AROUND THE DUMPSTER CLEAR OF TRASH AND DEBRIS
- DO NOT OVERFILL THE DUMPSTER
- BAG ALL TRASH OR DEBRIS BEFORE PLACING IN DUMPSTERS
- STORE/DISPOSE OF FOOD GREASE PROPERLY
- CALL THE CITY OF POULSBO TO REPLACE ANY LEAKING DUMPSTERS, DO NOT ALLOW DUMPSTER RUNOFF TO DRAIN INTO THE STORM DRAIN SYSTEM
- PER PMC 13.18.070(A) PROHIBITION OF ILLICIT DISCHARGES. IT IS UNLAWFUL FOR ANY PERSON TO THROW, DRAIN, OR OTHERWISE DISCHARGE, ANY MATERIALS OTHER THAN STORMWATER INTO THE MUNICIPAL STORM DRAIN SYSTEM AND/OR SURFACE AND GROUNDWATERS OF THE CITY.

ALL CONTAINERS WILL BE INSPECTED BY PUBLIC WORKS STAFF FOR COMPLIANCE.

## GARBAGE

### PLEASE FOLLOW THESE GUIDELINES:

- USE ONLY TOTES/DUMPSTERS PROVIDED BY THE CITY OF POULSBORO
- GARBAGE IS PICKED UP EVERY WEEK, INCLUDING ALL HOLIDAYS
- ALL TRASH MUST BE IN TIED BAGS
- IF YOU WISH TO INCREASE OR DECREASE YOUR TOTE/DUMPSTER SIZE, CALL **360.779.4078**
- EACH GARBAGE CUSTOMER IS RESPONSIBLE FOR THE TRASH RECEPTACLE(S) THAT HAVE BEEN PROVIDED.
- ALL TOTES/DUMPSTERS ARE NUMBERED AND RECORDED ON THE ACCOUNT.
- TOTES MUST BE OUT FOR PICK-UP BY 7:00 AM
- ALL TRASH MUST FIT IN THE TOTE WITH THE LID CLOSED; IF YOU HAVE EXTRA, TAGS CAN BE PURCHASED AT CITY HALL
- ALL TOTES MUST BE SPACED *THREE FEET* FROM OBSTACLES; FENCES/VEHICLES/MAILBOXES
- DUMPSTER/ENCLOSURES MUST BE UNLOCKED AND READY FOR PICK UP BY 7:00 AM
- IF WASTE PROTRUDES ABOVE THE LIP OF THE DUMPSTER, ADDITIONAL CHARGES WILL BE ASSESSED BASED ON THE DRIVER'S ESTIMATION OF EXTRA GARBAGE.
- IN THE EVENT THAT THE DUMPSTER IS DAMAGED (OTHER THAN NORMAL USE), THE CUSTOMER WILL BE RESPONSIBLE FOR THE COST OF REPLACEMENT.
