#### ORDINANCE NO. 2023-02

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 8.2.265 (B) OF THE POULSBO MUNICIPAL CODE IN ORDER TO CHANGE THE DAYS FIREWORKS CAN BE DISCHARGED, PROVIDING FOR SEVERABILITY, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council is concerned about public safety and desires to

protect the public from injuries and fires resulting from fireworks; and

WHEREAS, the City Council is concerned about the impacts of fireworks on

the environment and desires to minimize such impacts; and

WHEREAS, state law, Chapter 70.77 RCW and Chapter 212-17 WAC, generally

regulates the transfer, sale, possession, use, and discharge of fireworks within Washington

State; and

WHEREAS, under Chapter 70.77 RCW, the City Council is authorized to adopt

local fireworks ordinances that are more restrictive than state law, provided that such an ordinance does not take effect until at least one year after its adoption; and

WHEREAS, the City of Poulsbo desires to reduce the number of days

fireworks may be discharged and align the allowed dates of discharge around the Fourth of July holiday and New Year's Eve holiday with unincorporated Kitsap County;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO,

### WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1.** Hours of sale and discharge of fireworks. Subsection 8.20.265(B) of the Poulsbo Municipal Code is hereby amended to read as follows (strikethroughs indicate deletions, **bolding** indicates additions):

B. No person shall ignite, explode, use, burn, or discharge any fireworks at any time within the City except:

1. Between the hours of twelve o'clock noon and eleven o'clock p.m. on June 28 of each year;

2. Between the hours of nine **eleven** o'clock a.m. and eleven o'clock p.m. on each day from June 29th through July 4<sup>th</sup> of each year;

3. Between the hours of nine o'clock a.m. and nine o'clock p.m. on July  $5^{th}$  of each year; and

Between the hours of six o'clock p.m. on December 31st of each year and one o'clock a.m. on January 1 of the subsequent year.

**Section 2. Severability.** If any section, sentence, clause or phrase of this

ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 3. Effective Date.** In accordance with RCW 70.77.250(4), this ordinance shall take effect and be in force one year from the date of its passage and publication as required by law.
