1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mayor Erickson called the virtual meeting to order at 5:00 p.m. and led the Pledge of Allegiance.

3. COMMENTS FROM CITIZENS

Bill Austin said he likes the Sophie Building and the mural on the side by Stefan. He has spoken to Stefan about designing a concrete troll near the Home Depot. He also talked about buying Mr. Glen Anderson's property and turning it into a green space. When the upgrade is done, he would like it turned into a one-way street, with a serpentine flow and raised crosswalks.

4. MAYOR'S REPORT AND COUNCIL COMMENTS

Councilmember McVey said Mr. Austin will be featured on KOMO news tonight as part of Eric's Heroes. He congratulated Bill and thanked him for what he has done in 50 years.

Councilmember McGinty congratulated Bill.

Councilmember Stern got a copy of the book about Bill. He noted he attended the Good Neighbors lunch at the Suquamish Tribe along with other councilmembers.

Councilmember Lord said the Good Neighbors lunch had breakout sessions after the lunch that were really useful.

Councilmember Livdahl agreed the luncheon was great and shared about the breakout sessions.

Councilmember Musgrove agreed with the others' comments. The Suquamish people were wonderful hosts and very gracious. He learned about their concerns and their culture. It was great to visit with our neighbors again. He attended the WWU Poulsbo SBDC Cyber Security class at Olympic College. He attended the Salmon Tours event; it was well handled.

Mayor Erickson said she was sorry she couldn't attend the Tribe's event, she had to attend the Puget Sound Regional Council meeting to discuss the bi-partisan infrastructure law (\$1.9BB), and the allocation that is coming into our region and how they will split up the funds.

Public Works Director Lenius said they will start installation of the concrete panels on the retaining wall tomorrow for the Johnson Parkway project.

Mayor Erickson said she will invite them to come in costume.

Special Event Coordinator Wilson said they can do some story telling before the event so it can be a public notice to expect it, so they won't be so surprised.

Motion: Move to approve Ordinance No. 2022-15, an ordinance of the City of Poulsbo Washington levying the general taxes for the City of Poulsbo for the fiscal year commencing on January 1, 2023, on all property, both real and personal, in said city which is subject to taxation for the purpose of providing sufficient revenue to carry on the several departments of said city of the ensuing year as required by law and approving an ordinance summary for publication.
