1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

d. Ordinance No. 2010-25, Comprehensive Plan Amendments

Mayor Erickson stated the Planning Commission and Council have reviewed the amendments at a previously.

MOTION: McGinty/Lord. Move to adopt Ordinance 2010-25 an ordinance of the city of Poulsbo, Washington, adopting the 2010 Comprehensive Plan Amendments, redesignating and rezoning certain land located at 19047 3rd Avenue from Low Density Residential (RL) to Downtown Core (DC), amending policy LU-4.6 regarding live/work units, amending policy LU-5.1 to include Lions Park in the Park (P) designation, adding new text and policies to Chapter 11 regarding Comprehensive Plan Amendments, amending tables CFP-3, CFP-5 and CFP-6 and figure TR-3 to add and delete capital projects, adding new text in section 12.9 to describe the relationship between the Transportation Capital Facilities Plan and the Six-Year TIP, amending Policy CF-2.1, Table CFP-2, Section 12.10, and Table CFP-10 to revise the level of service for park and recreational facilities and to add and delete capital projects for Parks, Recreation and Trails, re-designating and rezoning certain land located on the NE corner of State Highway 305 and Bond Road from Residential Medium (RM) to Residential Medium with Master Plan Combining District (MP) overlay, providing for severability and establishing an effective date.

Motion carried unanimously. Absent: Berry-Maraist.

e. Baseline Adjustments and New Program Requests

Finance Director Booher reviewed the 2011 Baseline Adjustments and New Program Requests; and the Mayor's recommendations.

Council discussion included library funding for utilities and maintenance, funding for Eli's House, and re-establishing the Community Service program.

MOTION: Henry/Lord. Move to recommend funding of the selected Baseline Adjustment Requests and New program requests to be built into the 2011 Budget.

Motion carried unanimously. Absent: Berry-Maraist.
