A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE COST SCHEDULE FOR SERVICES PROVIDED BY THE POLICE DEPARTMENT.

WHEREAS, Poulsbo Municipal Code Section 3.12.040(C) authorizes the City Clerk to establish a Cost Schedule for other fees and to revise the schedule by Council resolution from time to time in order to reflect increases or decreases in costs of other fees; and

WHEREAS, the Police Department has determined certain changes should be made to the Cost Schedule to remove the fee for Service of Protection Orders issued under RCW 7.105 as they must be served at no charge; and increase the fee for Service of Civil Papers from \$30 to \$40 based on examination of current cost, benefits and wages; and

WHEREAS, the Police Department has determined any requests for an individual's criminal history are directed to contact the Washington State Patrol WATCH Program as the official source providing criminal history conviction records for the state of Washington and therefore this service is no longer applicable and therefore the corresponding fee has been removed; and

WHEREAS, the Police Department previously removed the Annual Alarm Registration requirement from PMC 9.12.055 and therefore the corresponding fee has been removed; and

WHEREAS, the Police Department no longer provides the services of lamination (card size) and therefore the corresponding fee has been removed; and

WHEREAS, the Police Department issues Federal Firearms Licenses for which the fees are set by statute RCW 9.41.110, currently as \$125.00 per licensee, this was not previously listed on the

cost schedule and therefore has been added; and

WHEREAS, the Police Department has determined the Off-Duty Officer rate has increased

from \$75.00 per hour to \$100.00 per hour based on examination of current cost, benefits and

wages; and

WHEREAS, the Poulsbo City Council has determined to amend the fee schedule effective

January 01, 2024, as provided hereinafter, now, therefore;

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS

FOLLOWS:

The Cost Schedule passed in Resolution No. 2019-01 is hereby amended and replaced with the
