

DESCRIPTION

THAT PORTION OF THE SOUTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 13, TOWNSHIP 26 NORTH, RANGE 1 EAST, W.M., IN KITSAP COUNTY, WASHINGTON, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTH QUARTER CORNER OF SAID SECTION 13, A CONCRETE MONUMENT; THENCE ALONG THE NORTH-SOUTH CENTER LINE OF SAID SECTION 13, NORTH 0°43'07" EAST 1314.23 FEET TO THE SOUTHEAST CORNER OF SAID SOUTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER: THENCE ALONG THE SOUTH LINE OF SAID SUBDIVISION NORTH 88°35'36" WEST 594.97 FEET TO THE TRUE POINT OF BEGINNING: THENCE CONTINUING NORTH 88°35'36" WEST 668.00 FEET TO A POINT 42.5 FEET EAST OF THE SOUTHWEST CORNER OF SAID SUBDIVISION: THENCE NORTH 43°52'48" WEST 60.405 FEET TO A POINT 42.5 FEET NORTH OF SAID SOUTHWEST CORNER: THENCE ALONG THE WEST LINE OF SAID SUBDIVISION NORTH O°50'00" EAST 48.37 FEET TO THE SOUTHEASTERLY RIGHT OF WAY OF LINCOLN HILL ROAD: THENCE NORTHEASTERLY ALONG SIAD RIGHT OF WAY ON A CURVE TO THE LEFT, THE CENTER OF WHICH BEARSNORTH 56°31'08" WEST 746.20 FEET AN ARC DISTANCE OF 201.22 FEET: THENCE NORTH 18°01'50" EAST 224.88 FEET: THENCE LEAVING SAID RIGHT OF WAY AND RUNNING PARALLEL WITH AND 150 FEET SOUTH OF THE NORTH LINE OF SAID SUBDIVISION, SOUTH 88°29'30" EAST 294.50 FEET: THENCE NORTH 1°30'30" EAST 150 FEET TO A POINT ON THE NORTH LINE OF SAID SUBDIVISION BEING SOUTH 88°29'30" EAST 250 FEET FROM SAID SOUTHEASTERLY RIGHT OF WAY OF LINCOLN HILL ROAD: THENCE ALONG THE NORTH LINE OF SAID SUBDIVISION SOUTH 88°29'30" EAST 250 FEET:
