**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DESIGNATING THE USA TODAY NETWORK | KITSAP SUN AS THE CITY'S OFFICIAL NEWSPAPER FOR THE TERM AUGUST 1, 2024 THROUGH JULY 31, 2026.**

**WHEREAS**, RCW 35A.21.230 requires the city to designate an official newspaper as provided in RCW 65.16 and the bidding laws of the State of Washington require that the official newspaper designation bids be called; and

**WHEREAS**, in accordance with state law, the bid was called for the City's official newspaper, the bids were reviewed and the USA Today Network | Kitsap Sun was found to be the lowest responsible bidder.

**WHEREAS**, the USA Today Network | Kitsap Sun in Poulsbo, Washington, is an acceptable newspaper under the regulations of RCW 65.16 and other state laws to serve as the City's official newspaper for the coming year, now, therefore,

**THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, RESOLVES AS FOLLOWS:**

**Section 1.** The USA Today Network | Kitsap Sun, which is located in Bremerton, Washington and has local circulation in the City of Poulsbo, is designated as the official newspaper of the City of Poulsbo, Washington for the term of August 1, 2024 through July 31, 2026.
