Request for Quotes (RFQ) Waterfront Park Concrete Replacement

Project Overview

The City of Poulsbo is soliciting quotes from qualified contractors to furnish and install approximately **2,700 square feet of 4-inch thick stamped and colored concrete** at Waterfront Park. The work will replace existing concrete surfaces and is scheduled to take place in **October 2025**. The Engineers estimate for this project is \$40,000.

Scope of Work

The selected contractor shall:

- Furnish and install approximately 2,700 square feet of 4" thick concrete.
- Provide all equipment, tools, and labor necessary to form, place, and finish the concrete.
- Ensure concrete meets the following specifications:
 - Must be ADA Compliant
 - o Minimum 3000 psi compressive strength.
 - Fiber mesh reinforced.
 - o **Integral color** (not surface stained). Contractor shall submit color palette for City approval prior to installation.
 - o **Stamped with a brick-like or rock/stone like pattern** Contractor shall submit pattern options for City Approval
- Coordinate with the City on project schedule and phasing.

Work Provided by the City

- Demolition and removal of existing concrete.
- Grading and Compaction of the work area.
- Finish restoration and cleanup of the work area (non-concrete related work)

Schedule

All work shall be completed by October 31, 2025, with exact dates coordinated with City staff.

Contractor Qualifications

Contractors must demonstrate:

• Experience with stamped and colored concrete installation.

- Ability to meet schedule and quality requirements.
- References from similar projects.

Contractor Requirements

- Prevailing wages be paid and documented in compliance with RCW 39.12.
- A Performance Bond be executed in compliance with RCW 39.08 before beginning work.
- The Contractor holds a current Washington State Contractor's License.
- Contractor must deliver a certificate of insurance naming the City as additionally insured before beginning work meeting the City of Poulsbo insurance requirements.
- Contractor must have a current City of Poulsbo Business License before beginning work.
- Contractor shall be in good standing regarding L&I premium payment prior to award of any contract.

Submittal Requirements

Interested contractors shall submit:

- 1. A written **quote** including total project cost and itemized breakdown.
 - Mobilization
 - Square Foot Price of Installed Concrete (including pumping if necessary)
- 2. Proposed concrete color palette(s).
- 3. Proposed stamped pattern
- 4. Proposed project timeline.
- 5. At least **two references** for similar concrete installation projects.
- 6. No Bid Bond is required for this submittal.
