## **ORDINANCE NO. 2025-23**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING ORDINANCE 2024-19, WHICH ADOPTED AND AMENDED THE CITY OF POULSBO'S BIENNIAL BUDGET FOR THE YEARS 2025-2026 BIENNIUM TO ADOPT A MODIFIED MID-BIENNIAL BUDGET AND APPROVING AN ORDINANCE SUMMARY FOR PUBLICATION.

**WHEREAS**, on December 18, 2024, the Poulsbo City Council adopted Ordinance Number 2024-19 which adopted the 2025-2026 biennial budget of the City of Poulsbo; and

**WHEREAS**, a mid-biennium budget modification was presented to the City Council in a timely manner for their review, in accordance with RCW 35A.34.130; and

**WHEREAS**, the City Council scheduled hearings on the biennial budget modification proposal for the purpose of providing information regarding estimates and programs; and

**WHEREAS**, the City Council held a public hearing on November 12, 2025, following required public notification, on the proposed mid-biennium budget modification; now, therefore

### **THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:**

**Section 1.** The biennial budget for the City of Poulsbo for the years 2025-2026, as adopted by Ordinance No 2024-19, is hereby modified to read as provided in the modified copy on file with the office of the City Clerk, which by this reference is hereby incorporated herein as if set forth in full. Upon the effective date of this ordinance, said modified biennial budget is hereby adopted in full.



with a copy of this amending ordinance, shall be transmitted by the City Clerk to the Division of Municipal Corporations of the office of the State Auditor and such other governmental agencies as provided by law.

**Section 4.** This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.
